SUBJECT: **PROCUREMENT OF ACCOUNTING AND BUDGET INFORMATION SYSTEM (ABIS)**

This Supplemental/Bid Bulletin No. 1 is hereby issued to clarify, modify, or amend items in the Bidding Documents. Accordingly, this shall form an integral part of the Bidding Documents.

ISSUES/QUERIES	CLARIFICATIONS/MODIFICATIONS/ ADDENDUM
1. There is inconsistency in the number of years indicated in Item 10.2 of the ITB (2 years) and Clause 3 number 3 of the Bid Data Sheet (5 years). Which one should be followed?	Item 10.2 of Section II (Instruction to Bidders) is hereby modified as follows: <i>“The Bidder’s SLCC as indicated in ITB Clause 5.3 should have been completed within five (5) years amounting to at least fifty percent (50%) of the ABC prior to the deadline for the submission and receipt of bids.</i>
2. Do you consider aggregation of completed contracts by the vendor – similar contract and same entity?	Yes, aggregation of completed contracts is allowed.
3. Clause 2.2 of the Special Conditions of Contract states “Please see ‘VIII. PAYMENT SCHEME’ in the attached Terms of Reference for the terms of payment.” However, there is no Section VIII. Payment Scheme in the Terms of Reference.	Please refer to page 3 of the attached Terms of Reference for the Procurement of Accounting and Budget Information System (ABIS)
4. Do you have prescribed bid forms for the following? - Bid Securing Declaration;	For the Bid Securing Declaration and Omnibus Sworn Statement please refer to the prescribed format by the GPPB.



<ul style="list-style-type: none"> - Omnibus Sworn Statement; - Statement of the prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started if any whether similar or not similar in nature and complexity to the contract to be bid; and - Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid. 	<p>For the Statement containing the prospective bidder's list of ongoing government and private contracts, as well as the statement of the bidder's SLCC, the NCIP BAC does not prescribe a standard format.</p> <p>It is sufficient that the bidder submits a list of all on-going government and private contracts in a form of matrix. However, the bidder must attach supporting document/s in relation to their Single Largest Completed Contract</p>
